CEO's Report

- a. AHA RPB Chair – Eric Moll shared he was interviewed for the AHA RPB Chair. He was not selected.
- b. CHOICE Leadership - Executive Director of CHOICE has resigned her position. This leaves CHOICE looking for new leadership. Eric Moll will be stepping back on the Executive Committee during the time they are looking for leadership.
- c. Virginia Mason Institute – Eric Moll shared that we are looking at working with VMI to help us with workflow and enhanced coaching for Nicole Eddins and Michele Tierney around our referral management. We have been able to negotiate to get Chris Backus as our sensai who has help us with our design for Mason Clinic. Gayle asked if this is something Cerner does referral management. That is one option, and we are looking at one other option. Looking at getting a recommendation by April 2022 but may take longer based on potentially working with VMI. Gayle asked about the annual wellness visits. Eric Moll shared we have forty scheduled at this time, which is more than we did all last year.

Through Mason Matters we are having discussion on women's health. Looking for community partners and how the hospital and Public Health can collaborative with a community partner to keep WIC (Women's, Infants, and Children) in our community.

Eric Moll provided an update on the nurse staffing bill.

Old Business –

- a. COVID Update – Melissa Strong provided a COVID Update. Our vaccination rate for Mason County is 61%. 131 deaths. Average COVID patient census is about 1 the last few weeks. We had zero test positive yesterday at Mason Health. Darrin Moody would like to make sure we are communicating to staff even though Governor Inslee is removing mask mandate, it will not be removed from healthcare.

New Business –

- a. Budget Amendment – Mel Strong recommended to increase to the 2022 Capital Budget in the amount of \$260,171 for the purchase to upgrade the Emergency Department Patient Monitoring System.

Administration Roundtable

Effective March 1, 2022, Patrick O'Neil will take over managing the security, safety events, policy & procedures, environmental of care. Employee Safety will still be under Pam Schlauderaff.

In February, we received almost \$3M in American Recovery Grant. Both are on the balance sheet, but we have not put them on the balance sheet under income yet.

The financial draft audit will be presented to the financial committee and Board of Commissioners in April 2022.

Dean Gushee shared that his focus has been working with Skyline on the conversion to our domain to make sure it is clean. We may extend our ITWORKS model team to help with a smooth transition, but it cannot impact our needs.

Dean Gushee shared that he is very thankful for our team around cybersecurity with what is going on in the world today. Cerner is going back to in-person conferences.

Mel Strong shared that we currently have 7.8 positions opened in nursing. For the district we currently have 80 open position totaling 37 FTEs.

Administration roundtable (continues)

One of the nursing candidates received interview with the Embassy and hoping that she will be here 2nd quarter working in MSP.

88% of our patients did indicate that they would refer our Emergency Department to a family or friend. Mel Strong has been meeting with Dena from High School. Those two are doing media trying to draw attention to Health Science Academy.

Gayle Weston asked about the backlog in DI. Rick Smith believes that the back log is going better well right now.
