Shelton Chambers of Commerce Gala:

Darrin and I attended the Shelton Chambers of Commerce Gala on April 29th. This Gala has grown substantially since I last attended. I came away very impressed with how well the Gala brought together many different parts of our community. I would like to suggest that Mason Health sponsor one or two tables next year.

Shelton School District Superintendent:

I met with Wyeth Jesse, Shelton School District Superintendent, on April 28th to discuss among other topics our shared interest related to the Health Science Academy. I came away from that conversation impressed with Wyeth's strategic commitment to the Health Science Academy.

COO

On Wednesday, May 4, we received the signed Physician Agreement from Dr. David Soha. Dr. Soha is a Primary Care Physician completing residency this fall in Ohio. He was raised in Shelton, and his mother still lives in town. We anticipate Dr. Soha joining us in October or early November and are highly confident he will be a great fit for our organization. His visit in April went very well and all those who interacted with Dr. Soha encouraged us to pursue his employment.

On Thursday, May 5, Dr. Cuevas and I visited the Skokomish Indian Tribe's Medical Clinic. As has been reported previously, we are executing an agreement with the Tribe for Dr. Cuevas to provide medical services to the tribal population one day per week at their clinic. Dr. Cuevas will also work closely providing consultations with the Tribe's Nurse Practitioners. I will give an update on this visit at the Board of Commissioners meeting.

CNO

Staffing: we had three applicants for our workforce programs. All three tracks had applicants. Mason Health's interview panel conducted interviews on Thursday 5/5. All applicants had exceptional application packets and recommendations. The awards will be given at a press event on May 11th just prior to the barbeque. Our first passport candidate has an appointment with the consulate the beginning of June and will begin the visa process. We've reposted open positions and added sign on bonuses for those open more than 30 days. CNA 0.9FTE days, ICU FTEs, and 0.8FTE RT variable shift currently have sign on bonuses. RN openings: 0.9 ICU, 0.3 ED, 0.6 ICU, 0.8 Surgery. The ICU positions have been open for >30 days. We are also promoting the referral bonuses.

Union negotiations continue. We had one meeting on May 2nd. Our next meeting is scheduled for the afternoon of May 11th. The Union did present their proposal of 25% across the board increases. We countered with our variable market increases depending on job (all based on market). We also offered a 700\$ retention bonus. The members seemed receptive but needed time to process. Historically we have done ATB increases. There were no significant asks or contention points.

Swing Bed: retraining is occurring and MSP will be ready to accept June 1st.

We will also begin pulmonary function testing again. This was stopped during the pandemic because it's considered a high-risk procedure because of the respiratory aerosolization that occurs during testing. The RT department will test each patient prior to performing the procedure. This service will begin again June 1st as well.

Community: I am currently building relationships with the Sheriff's department and City Police. The Behavioral Health crisis has created some tension between our ED and Law Enforcement because of lack of understanding and miscommunication. Kristyn and I are scheduled to attend a training session for the Sheriff's department the beginning of June. I'm hopeful this will help with misunderstandings and begin to strengthen our relationships with our community partners.

Covid- We've had 8 covid positive staff members. We've had 0 covid positive patients.
