Over the course of three and a half days the week of June 27, a Kaizen Event was held focusing on the process and timing of completing internal and external referrals. This event was led by representatives from Virginia Mason Institute and our own Kaizen Promotion Office. Participants included staff from the Referrals Department, Physical Therapy, Diagnostic Imaging Scheduling and Medical Assistants. At the conclusion of the event, each of the staff members gave a brief report on what was identified to improve upon and what they learned during this process. Overall, this event is considered a success, although much work remains to put new processes in place, while defining roles, tasks, and steps in completing a referral. The target to schedule a referral is 72 hours, of which we are quite a way off for a variety of reasons. Coming out of this event, an Action Plan was developed with next steps to serve as a roadmap until the group may need to reconvene. This initiative is being led in a Dyad Relationship between Nicole Eddins and Mason’s Director of Clinic Operations, Michele Tierney.

CHOICE Regional Health Network- Executive Director:

CHOICE has hired J.P. Anderson as the next executive director. J.P. was previously the Public Health Officer for Lewis County. CHOICE is a seven-county network of hospitals, federally qualified health clinics and county health departments focused on promoting population health throughout the seven-county region. Both Mason Health and Mason Public Health are board members of CHOICE. As a reminder from our board conversation with David Windom, much of the federal and state funding for a Blue Zones initiative for Mason County is coming through CHOICE.
